2. Pre-Deposit Account (PDA): Facility of Pre-Deposit Account (PDA) is available at all Adani Logistics facilities to help our customers carry-out their commercial transactions with ease. All customers are requested to have their Pre-Deposit Account created and also maintain sufficient balance at all time for services opted (Rail, Road, Warehousing or any Terminal Services). 3. 20' : Handling of containers with gross weight above 27 MT will be 1.25 times of the tariff rate & above 30 MT will be charged 2 times on all activities.
4. 40' : Handling of container with gross weight above 30 MT will be charged 1.25 times on all activities.
5. Rates indicated for 20Ft also applies for 22 Ft and where rates are indicated for 40Ft also applies for 45Ft.
6. For hazardous/Reefer/Tank containers, an additional 50% will be charged for all activities.
7. For ODC consignments the rates are minimum double of the normal THC and also subject to dimensions.
8. Fuel Surcharge will be subject to diesel price.
