Sirs,

This is to bring it to the notice of all concerned that Port Health Officer, Kandla will continue to monitor the documents submitted by all the Ships in Gujarat waters and will continue to give mail clearance, on ship to ship basis, to the healthy ships.

The suspected ships advised for COVID-19 screening <u>at minor ports</u>, will be attended and screened by the team of the designated Health Officer of the State Government of the respective port or Port Medical Officer, if available. This team will also follow the screening of the Signing Off of the crew, if required (proforma forself reporting form is attached).

In case of any Covid-19 symptomatic crew, the guidelines will follow as per earlier SOP.

The concerned Agent of the ship, at minor port, will co-ordinate with the team of designated State Government Health Officer of the respective port for Screening of the ships/crew and will give intimation to the PHO Kandla by sending copies of crew list with temperature recorded for each crew after screening of the ship by mail or WhatsApp whichever is convenient.

In this connection, kindly see the attached letter received from Jt.Secretary, Min...of H&FW,New Delhi.

In respect of Covid-19 suspected ships, limited pratique will be granted by Custom/Port authorities and for other ships Free Pratique will be granted as per earlier practice.
