Dear Sir,

AKPL has restructured its Marine and Harbour services and accordingly inducting a Company by name and style of "The Adani Harbour Services Limited" referred as **TAHSL** having **CIN: U61100GJ2009FLC095953; PAN: AADCT2719D** and **GSTIN: 37AADCT2719D1ZJ** to commence its operation at Krishnapatnam Port.

Now services related to Pilotage, Towage and Tugs at Adani Krishnapatnam Port will be provided and managed by **TAHSL**. Thus, all charges for providing such services will be billed by **TAHSL** (List attached).

We would like to inform and confirm to all our esteemed customers that due to this restructuring there is no any additional financial implications and Vessels will be continued to be charged as per existing tariff of AKPL BPTS.

Now onwards, the customers will be receiving two invoices simultaneously, one raised by **TAHSL** for services related to Pilotage, Towage and Tugs; and another raised by **AKPL** for services related to Port Dues, Berth Hire, Anchorage and other services, if any.

Since both the business entities have separate bank accounts, the payment has to be remitted to the respective accounts. The details of **TAHSL** are as follows.
