Sub: Fuel and Power Purchase Price Adjustment (FPPPA) calculation for Q4 of FY22

Dear Sir,

With reference to the above subject, we hereby submit the calculation of FPPPA for Q4 of FY22 duly certified by the Auditors, considering power purchase cost and FPPPA formula approved by Hon'ble GERC vide its order dated 01.04.2021 in the Petition No. 1924 / 2021.

As per the Auditor's certificate, FPPPA charges worked out to be Rs. 0.03 per unit. Accordingly, we shall recover FPPPA charges of Rs. 0.03 per unit during Q1 of FY23 which is less by Rs. 0.67 per unit as compared to FPPPA charges of Rs. 0.70 per unit of Q4 of FY22. Any difference in actual power purchase cost with respect to approved power purchase cost will be considered in the truing up of FY 22 and FY 23.

In view of the above, we humbly submit here that MPSEZ Utilities Limited shall recover FPPPA charges @ Rs. 0.03 per unit with effect from 01.04.2022 and shall continue the same for the Q1 billing quarter of FY23.
