**Sub: Fuel and Power Purchase Price Adjustment (FPPPA) calculation for Q2 of FY22**

Dear Sir,

With reference to the above subject, we hereby submit the calculation of FPPPA for Q2 of FY22 duly certified by the Auditors, considering power purchase cost and FPPPA formula approved by Hon'ble GERC vide its order dated 01.04.2021 in the Petition No. 1924 / 2021.

As per Auditor's certificate, FPPPA charges come to Rs. 0.04 per unit. Accordingly, we shall recover FPPPA charges at Rs. 0.04 per unit during Q3 of FY22 which is decrease recovery of FPPPA charges by Rs. 0.10 per unit for Q3 billing of FY22, over recovery of FPPPA charges @ Rs. 0.14 per unit submitted to Hon'ble Commission and recovered accordingly for Q2 of FY22, in view of directives given by the Hon'ble Commission for recovery of FPPPA charges in its Tariff Order dated 1<sup>st</sup> April, 2021. Any difference in actual power purchase cost with respect to approved power purchase cost will be considered in truing up of FY22.

In view of above, we humbly submit here that MPSEZ Utilities Limited shall recover FPPPA charges @ Rs. 0.04 per unit with effect from 1<sup>st</sup> October, 2021 and shall continue the same for Q3 billing quarter of FY22.
