Adani Vizhinjam Port Pvt. Ltd. (AVPPL) vide No. 1416/EC1/2019/SEIAA dated 27.02.2020.

The general conditions of the EC, Point No. 27 states that "proponent shall submit half yearly reports in soft copy and SEIAA will upload it on the website".
