Sub- Local Cautionary Signal Number III – Weather Alert and Safety Measures

Dear Sirs,

As per the **India Meteorological Department (IMD)** notification issued by the Cyclone Warning Centre, Thiruvananthapuram, on May 25, a well-marked low-pressure area persists over south Madhya Maharashtra and adjoining areas of Marathwada and North Interior Karnataka. This system is expected to move slowly eastwards and weaken gradually over the next 24 hours. However, squally weather with high wind speeds, is likely to prevail along the Kerala coast, **including Kerala Southern Coast which include Vizhinjam, and adjoining areas.**

The IMD has hoisted **Local Cautionary Signal Number III** for all Kerala ports, including **Adani Vizhinjam Port Private Limited (AVPPL)** indicating potential adverse weather impacting maritime operations.

All vessels in port, those scheduled to call, and other stakeholders are advised to adhere to the safety precautions including but not limited to **Secure Mooring (Including additional mooring lines for safety, Navigation Caution, Crew Alertness, Anchorage Monitoring, Cargo and Equipment Safety, Operational Continuity, Communication, Emergency Preparedness etc.**

AVPPL is monitoring updates from IMD Cyclone Warning Centre, Thiruvananthapuram, Updates will be communicated via:

- Trade circulars and port notices.
- Weather Updates (6 Hourly) Via Email notifications to registered stakeholders.

Adani Vizhinjam Port Private Limited (AVPPL) is continuously monitoring the weather conditions & implementing precautionary measures to ensure the safety of vessels, personnel, cargo, and infrastructure. In case if weather conditions get worse, based on IMD updates port may increase warning to **Signal 4 or above** (indicating a cyclonic storm closer


